### **XI. INTRODUCTION**

This document includes Environment and Ecology standards that describe what students should know and be able to do in these areas:

- ◇ 4.1. Ecology
- ◇ 4.2. Watersheds and Wetlands
- ◇ 4.3. Natural Resources
- ◇ 4.4. Agriculture and Society
- ◇ 4.5. Humans and the Environment

The Declaration of Rights, Article I of the Pennsylvania Constitution states in Section 27: “The people have a right to clean air, pure water, and to the preservation of the natural, scenic, historic and aesthetic values of the environment. Pennsylvania’s public natural resources are the common property of all people, including generations yet to come. As trustee of these resources, the Commonwealth shall conserve and maintain them for the benefit of all the people.” To this end it is our responsibility to develop a citizenry that is aware of and concerned about the total environment and has the knowledge and skills to work toward solutions to current problems and the prevention of new ones.

Environment and Ecology is grounded in the complexity of the world we live in and its sustainability. It examines the world’s natural processes and systems. Environment and Ecology places its main emphasis in the real world. Allowing students to understand, through a sound academic content base, how their everyday lives evolve around their use of the natural world and the resources it provides.

These standards establish the essential elements of what students should know and be able to do at the end of grades four, seven, ten and twelve. The sequential nature of this document reflects the need for rigorous academic content that students will be expected to achieve. The document reinforces all areas across the grade levels with increasing degrees of difficulty as the students mature intellectually.

The study of Environment and Ecology will allow students to be active participants and problem solvers in real issues that affect them, their homes, schools and communities.

A glossary is included to assist the reader in understanding terminology contained in the standards.

## Environment and Ecology

**Science as Inquiry:** Understanding of science content is enhanced when concepts are grounded in inquiry experiences. The use of scientific inquiry will help ensure that students develop a deep understanding of science content, processes, knowledge and understanding of scientific ideas, and the work of scientists; therefore, inquiry is embedded as a strand throughout all content areas. Teaching science as inquiry provides teachers with the opportunity to help all students in grades K-12 develop abilities necessary to understand and do scientific inquiry. These are very similar across grade bands and evolve in complexity as the grade level increases.

**XII. GLOSSARY**

<b>Abiotic:</b>	A nonliving factor or element (e.g., light, water, heat, rock, energy, mineral).
<b>Agriculture:</b>	The production of food, feed, fiber, and other goods by the systematic growing/harvesting of plants, animals and other life forms.
<b>Best Management Practices (BMP):</b>	Methods that have been determined to be the most effective, practical means of preventing or reducing pollution and improving efficiency.
<b>Diversity index</b>	A mathematical means of determining how many different species exist in a particular environment in order to determine environmental health.
<b>Biogeochemical:</b>	The movement of chemical elements between organisms and non-living compartments of atmosphere, aquatic systems, and soils.
<b>Biological Diversity (Biodiversity):</b>	The variety and complexity of species present and interacting in an ecosystem and the relative abundance of each.
<b>Biomes:</b>	Distinct ecological communities of plants and animals living together in a particular climate.
<b>Biofuels:</b>	Renewable fuels derived from biological materials that can be regenerated.
<b>Biotic:</b>	An environmental factor related to or produced by living organisms.
<b>Buffer Zone:</b>	A designated land or water area, along the perimeter of some land use, the use of which is regulated so as to resist, absorb, or otherwise preclude unwanted development or other intrusions (visual, noise, recreational use) into areas beyond the strip of undisturbed vegetation that retards the flow of runoff water, causing deposition of transported material and thereby reducing sediment in receiving streams.
<b>Carrying Capacity:</b>	The maximum population that can be sustained indefinitely in a given area without changing the ecosystem in ways that will eventually reduce the sustainable population.
<b>Consumer:</b>	Organisms that obtain energy by feeding on other organisms and their remains.
<b>Desertification:</b>	A process of landscape change usually due to land mismanagement whereby the land becomes increasingly arid and vegetation is replaced by more dry-adapted species.

<b>Decomposer:</b>	An organism, often microscopic in size, that obtains nutrients by consuming dead organic matter, thereby making nutrients accessible to other organisms; examples of decomposers include fungi, scavengers, rodents, and other animals.
<b>Ecosystem:</b>	A community of living organisms and their interrelated physical and chemical environment.
<b>Endangered Species:</b>	A species that is in danger of extinction throughout all or a significant portion of its range.
<b>Environment:</b>	The total of the surroundings (air, water, soil, vegetation, people, wildlife) influencing each living being's existence, including physical, biological and all other factors; the surroundings of a plant or animal, including other plants or animals, climate and location.
<b>Extinction:</b>	The complete elimination of a species from the earth.
<b>Fiber</b>	Parts of plants and animals used for non-food products.
<b>Food Web:</b>	The set of organism relationships, often based on who-eats whom or which organisms cycle a particular nutrient within and ecological community.
<b>Food and Fiber System:</b>	Food and fiber systems, or agriculture, encompass all the processes necessary to bring food and fiber products to the consumer; including production, processing, research, development, distribution, and marketing.
<b>Habitat</b>	Consists of food, water, shelter, and space in a suitable arrangement.
<b>Integrated Pest Management:</b>	A variety of control methods including cultural, mechanical, biological, and chemicals to control pest population.
<b>Lentic:</b>	Relating to or living in still water.
<b>Limiting Factors:</b>	Chemical or physical factors that limit the existence, growth, abundance, or distribution of an organism.
<b>Lotic:</b>	Relating to or living in actively moving water.
<b>Matter:</b>	The substance of which physical objects are composed; it constitutes much of the observable universe (excluding light). It is normally defined as anything that has mass and takes up space.
<b>Mitigation:</b>	The policy of constructing or creating man-made habitats, such as wetlands, to replace those lost to development.

<b>Monoculture:</b>	The system of growing only one crop in a given area.
<b>Natural Resources:</b>	Any material produced by nature that can be used to produce goods or provide services.
<b>Niche (Ecological):</b>	The role played by an organism in an ecosystem; its food preferences, requirements for shelter, special behaviors, and the timing of its activities (e.g., nocturnal, diurnal), interaction with other organisms and its habitat.
<b>Non-Point Source Pollution:</b>	Contamination that originates from many locations that all discharge into a location (e.g., lake, stream, land area).
<b>Nonrenewable Resources:</b>	Substances (e.g., oil, gas, coal, copper, gold) that, once used, cannot be replaced in this geological age.
<b>Organism:</b>	A form of life considered as an entity; an animal, plant, fungus, protist, or bacteria.
<b>Pest:</b>	A label applied to an organism when it is in competition with humans for some resource.
<b>Point Source Pollution:</b>	Pollutants discharged from a single identifiable location (e.g., pipes, ditches, channels, sewers, tunnels, containers of various types).
<b>Predators:</b>	Animals that live by capturing and feeding on other animals.
<b>Prey:</b>	Animal hunted or caught for food.
<b>Producers:</b>	Plants that perform photosynthesis and provide food to consumers.
<b>Population Dynamics:</b>	A description of the ways in which a given population's numbers grow and shrink over time, as controlled by birth, death and emigration.
<b>Recycling:</b>	Collecting and reprocessing a resource or product to make new products.
<b>Regulation:</b>	A rule or order issued by an executive authority or regulatory agency of a government and having the force of law.
<b>Renewable Resource:</b>	A naturally occurring raw material or form of energy that will be replenished through natural ecological cycles or sound management practices (e.g., the sun, wind, water, trees).

## GRADES 3-8, 10, 12

### Environment and Ecology

<b>Risk Management:</b>	A strategy developed to reduce or control the chance of harm or loss to one's health or life; the process of Identifying, evaluating, and selecting and implementing actions to reduce the risk to human health and to ecosystems.
<b>Symbiotic:</b>	Intimate relationship between two organisms often resulting in mutualism (win-win), parasitism (win-lose), or commensalism (win-no harm).
<b>Stream Order:</b>	Energy and nutrient flow that increases as water moves toward the oceans [e.g., the smallest stream (primary) that ends when rivers flow into oceans].
<b>Succession:</b>	The series of changes that occur in an ecosystem with the passing of time.
<b>Sustainability:</b>	The ability to keep in existence or maintain. A sustainable ecosystem is one that can be maintained.
<b>Technology:</b>	The application of knowledge to the practical aims of human life or to changing and manipulating the human environment. Technology is a broad concept that deals with a species' usage and knowledge of tools and crafts, and how it affects a species' ability to control and adapt to its environment.
<b>Textile</b>	A flexible material comprised of a network of natural or artificial fibers.
<b>Topography:</b>	The physical features of a place or the study and depiction of physical features, including terrain relief.
<b>Water Cycle:</b>	The cycle by which water evaporates from soils, vegetation, oceans, and other bodies of water; accumulates as water vapor in clouds; returns to the Earth, oceans, and other bodies of water as rain and snow; and runs off as river flow, through the soil or an aquifer.
<b>Waste Management:</b>	Administration of the reduction, collection, separation, storage, transportation, transfer, processing, treatment, and disposal of wastes.
<b>Watershed:</b>	The land area from which surface runoff drains into a stream, channel, lake, reservoir, or other body of water; also called a drainage basin.
<b>Waste Stream:</b>	The flow of (waste) materials from generation, collection, and separation to disposal.
<b>Wetlands:</b>	Lands where water saturation is the dominant factor determining the nature of the soil development and the plant and animal communities (e.g., sloughs, estuaries, marshes).
