

AFFIDAVIT OF THE SUPERVISOR OF A SECONDARY HOME EDUCATION PROGRAM

I attest that the following courses shall be taught at the secondary school level: English, to include language, literature, speech and composition; science; geography; social studies, to include civics, world history, history of the United States and Pennsylvania; mathematics, to include general mathematics, algebra and geometry; art; music; physical education; health; and safety education, including regular and continuous instruction in the dangers and prevention of fires in keeping with the requirements of 24 P.S. §13-1327.1(d). Such courses of study may include, at the discretion of the supervisor of the home education program, economics; biology; chemistry; foreign languages; trigonometry; or other age-appropriate courses. 6. I attest that the education objectives in the home education program are organized by subject area as attached to this affidavit. (Ref. 24 P.S. §13-1327.1(b)(1))

[Article XIV requires that every child of school age be given by methods established by the state's Advisory Health Board (test requirements are found at 22 Pa. Code §51.14-15 and 22 Pa. Code §51.20), a vision test, a hearing test, a measurement of height and weight, tests for tuberculosis under medical supervision and other tests required by the Advisory Health Board. Children upon entry into school and in the 6<sup>th</sup> and 11<sup>th</sup> grades must have a medical examination

and comprehensive appraisal of health by a physician. Children upon entry into school and in the 3<sup>rd</sup> and 7<sup>th</sup> grades must have a dental examination by a dentist. - p. Section 4302 (relating to incest).
- q. Section 4303 (relating to concealing death of a child).
- r. Section 4304 (relating to endangering welfare of children).
- s. Section 4305 (relating to dealing in infant children).
- t. A felony offense under Section 5902(b) (relating to prostitution and related offenses).
- u. Section 5903(c) or (d) (relating to obscene and other sexual materials and performances).
- v. Section 6301(A)(1) (relating to corruption of minors).
- w. Section 6312 (relating to sexual abuse of children).
- x. Section 6318 (relating to unlawful contact with minor).
- y. Section 6319 (relating to solicitation of minors to traffic drugs).
- z. Section 6320 (relating to sexual exploitation of children).
- aa. An offense designated as a felony under the act of April 14, 1972 (P.L. 233, No. 64) known as “the Controlled Substance, Drug, Device and Cosmetic Act.”
- bb. An offense similar in nature to those crimes listed above under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of the Commonwealth.
